

# Pennsylvania QSO Party 2025 Rules

## 1. Purpose of the QSO Party

- 1.a. Pennsylvania amateurs operating in the State of Pennsylvania, without regard to the amateur's home address, contact as many other amateurs in Pennsylvania, the United States, Canada, and the world.
- 1.b. Non-Pennsylvania Amateurs try to contact as many Pennsylvania Amateurs as possible.

## 2. Operating Periods

- 2.a. For the year 2025: 1600Z (1200EDT) October 11 to 0400Z (Midnight EDT) October 12, and 1300Z (0900EDT) October 12 to 2200Z (1800EDT) October 12.

## 3. Bands

- 3.a. QSOs are permitted on all ham band allocations authorized by station licensee, including 630m and 2200m and any VHF/UHF/Microwave frequencies, except as noted below in Section 3.b. Primary activity for the PA QSO Party has typically been on 160m, 80/75m, 40m, 20m, 15m, 10m, 6m, and 2m.
- 3.b. QSOs are **not** permitted on the WARC bands (12m, 17m, 30m, or 60m).
- 3.c. QSOs are **not** permitted via repeaters, satellites, EchoLink, IRLP, or similar VoIP services.

## 4. Suggested Frequencies

- 4.a. Phone: Portions of the Phone Bands allocated to General licensees on 160M, 80M, 40M, 20M, 15M and 10M. Use generally recognized calling frequencies on VHF.
- 4.b. CW: 40 KHz up from the bottom of the band and 1810 KHz.
- 4.c. DELETED
- 4.d. 160m High Activity: 0300Z Sunday (Saturday night 2300EDT).
- 4.e. Other High Activity Periods (Sat and Sun): 10M – 1800Z (1400EDT), 15M – 1900Z (1500EDT), 20M – 2000Z (1600EDT), Phone on the hour, CW on the half hour.
- 4.f. Mobile Window: Keep these areas clear for mobiles:
  - 4.f.1. CW: 5 – 15 KHz below listed suggested frequencies.
  - 4.f.2. Phone: 5 – 15 KHz above bottom edge of General Phone band.

## 5. Exchange / QSO

- 5.a. Sequential serial number plus PA county, ARRL section, Canadian section, or "DX". Serial numbers may be sent out of order or skipped due to software serial number reservation systems. It is important to correctly record the serial number that was sent and correctly copy the serial number received from the other station.
- 5.b. Logged exchanges must conform to the specified Pennsylvania County or the ARRL/Canadian section abbreviations listed below. The PA County abbreviations are listed at the following URL: <https://paqso.org/pa-cntys-arrrl-sects.html>.
- 5.c. Multi-stations can send QSO number by band.
- 5.d. Work stations once per band and mode.
- 5.e. Work Rovers and Mobiles again when they change counties.
- 5.f. Log QSO time / date in GMT.

- 5.g. **Accurate logging is important.** Accurate QSO time, date, sent serial number, and band/mode are as important as the received QSO exchange. QSO points may be lost for inaccuracies or errors in any portion of the QSO line.
- 5.h. To receive credit for a QSO, the following information must be recorded without error and reported per the Cabrillo Specification (<https://wwrof.org/cabrillo/cabrillo-qso-data/>):
  - 1. Received and transmitted callsigns
  - 2. Received and transmitted serial numbers
  - 3. Received and transmitted locations as defined in Paragraph 5.a
  - 4. Frequency
  - 5. Mode
  - 6. Time and date

## 6. Scoring QSO Points

- 6.a. CW: 2 points/QSO
- 6.b. DELETED
- 6.c. Phone: 1 point/QSO
  - 6.c.1. SSB, FM, AM, etc. Any voice mode allowed per FCC Regulations.
  - 6.c.2. QSOs made using multiple voice modes on the same band only count once.

## 7. Entry Divisions

- 7.a. Single Op High Power – CW
- 7.b. Single Op Low Power – CW
- 7.c. Single Op QRP – CW
- 7.d. Single Op High Power – Phone
- 7.e. Single Op Low Power – Phone
- 7.f. Single Op QRP – Phone
- 7.g. Single Op High Power – Mixed Mode
- 7.h. Single Op Low Power – Mixed Mode
- 7.i. Single Op QRP – Mixed Mode
- 7.j. Multi Op – High Power
- 7.k. Multi Op – Low Power
- 7.l. Multi Op – QRP
- 7.m. Portable – Single Op High Power (In-State Only)
- 7.n. Portable – Single Op Low Power (In-State Only)
- 7.o. Portable – Single Op QRP (In-State Only)
- 7.p. Portable – Multi Op High Power (In-State Only)
- 7.q. Portable – Multi Op Low Power (In-State Only)
- 7.r. Portable – Multi Op QRP (In-State Only)

- 7.s. Rover – Single Op (In-State Only)
- 7.t. Rover – Multi Op (In-State Only)
- 7.u. Mobile – Single Op (In-State Only)
- 7.v. Mobile – Multi Op (In-State Only)
- 7.w. County Line – Single Op (In-State Only)
- 7.x. County Line – Multi Op (In-State Only)

## 8. Power Categories

All power levels are defined as the output power of the transmitter and do not include losses of filters, feedlines, switches, etc.

Power category is defined by the highest power used for any of the contacts during the Party. Power levels are defined as follows:

- 8.a. High Power: greater than 100 Watts up to legal limit
- 8.b. Low Power: greater than 5 Watts up to 100 Watts
- 8.c. QRP: 5 Watts maximum

## 9. Station Definitions & Entry Categories

- 9.a. A Home Station is a station that is operated from a fixed position. It does not need to be a domicile. Club Stations are considered home stations. Cabrillo files with Category-Station set to **FIXED** will be assigned to the Entry Categories 7.a through 7.l above.
- 9.b. A Portable Station is a temporary station that is set up in a single county for the QSO party with the intention of tear-down post party. The use of permanent amateur station antenna(s) or tower(s) is not permitted by a Portable station. The typical portable station would be operation from a camp cabin, recreational vehicle, or tent with temporary antennas installed for the QSO Party. The power source is not restricted. Cabrillo files with Category-Station set to **PORTABLE** will be assigned to the Entry Category of Portable.
- 9.c. Mobile Station is a station that is capable of operation in motion with antennas generally accepted as mobile antennas. All equipment used for making contacts must be carried and/or towed by the vehicle, including antennas and power sources. Mobile stations are not required to operate while in motion but must operate within the Commonwealth of Pennsylvania. This does not exclude mobile operation outside of Pennsylvania, but no mobile bonus is allowed for out-of-state mobiles. A Mobile Single-Op station is one single operator, while a Mobile Multi-Op Station is an operator plus a driver, who is either only driving or another operator. A Mobile Station does not operate from a county line. Mobile stations submit a single Cabrillo 3.0 log containing contacts from all counties operated and their scores will be listed in the Mobile category results. In addition, a separate score will be shown for each county operated by the Mobile achieving more than 10 QSOs in that county; this score will be calculated from the QSOs, QSO points, multipliers, and bonus station points earned in each county on a standalone basis.
- 9.d. A Rover Station is a station that is capable of moving from one place to another, but is typically using an antenna that is set up on site, then torn down and moved to another site. All equipment used for making contacts must be carried and/or towed by the vehicle, including antennas and power sources. Rovers do not operate as a mobile in

route between locations. A Rover Station does not operate from a county line. Rover stations must travel 5 miles or more between stops to be eligible for the 500 point bonus. Rover stations submit a single Cabrillo 3.0 log containing contacts from all counties operated and their scores will be listed in the Rover category results. In addition, a separate score will be shown for each county operated by the Rover achieving more than 10 QSOs in that county; this score will be calculated from the QSOs, QSO points, multipliers, and bonus station points earned in each county on a standalone basis.

- 9.e. A County Line station position is situated very near the boundaries of at least two or more adjacent counties. Ideally an antenna should cross the boundary, but this is not always practical because many boundaries are in the middle of rivers or highways. The station must be set up as near as practical to the adjacent borders and is fixed for the entire QSO Party. County Line stations may be a Home Station. Party officials are available to determine admissibility of any county line station setup. A County Line station sends a single report with the multiple county abbreviations (CAR/LEH). The County Line and receiving station logs a QSO for each county. Both stations receive QSO points for each QSO entry. If possible, the County line station should log these QSO's with the serial number as sent. There may be small differences in the sent and received serial number due to differences in logging programs or the automatic expansion of county line compound exchanges into separate QSO's. This is acknowledged and accepted. Mobile, Rover, and Bonus stations are not eligible to be a County Line station. County Line station scores will not be included in the individual county score listings of the results write-up. Note: The Cabrillo Standard does not include a station category for County Line but it can be selected during the log submission process.
- 9.f. Multi-Operator stations are stations operated by two or more operators. The operations may occur at a single location or multiple locations. All operators must be located in the same county (PA stations) or section (non-PA stations). Operators must share log data to minimize the potential for duplicate contacts, have only one transmitted signal on any given mode/band combination at a time, submit a single, combined log, use a single call and select one power category corresponding to the highest power used by any of the operators. Multi-stations can send QSO number by band. Multi-op stations at multiple locations may NOT send serial numbers by location; sending the same serial number at multiple locations by band may result in a check log. This definition only applies to the six Multi-Op and Portable entry divisions. All County Line, Mobile, and Rover Multi-Operator divisions must be collocated. The Cabrillo file Category-Operator field should be set to MULTI-OP for all multi-op categories shown in Section 7.
- 9.g. A base callsign (normalized callsign) may be used in only one category for score credit. Any QSOs made using that callsign in additional categories will not count but must be submitted as a checklog.
- 9.h. Single Operator High Power, Low Power, and QRP Mixed Mode logs must contain both Phone and CW QSOs that are determined to be valid after log checking. If the log only contains valid QSOs made using one mode, then it will automatically be reclassified to the appropriate single mode category.
- 9.i. Single operator categories are allowed only one transmitted signal at any time.

## 10. Multipliers and Scoring

- 10.a. In-State Multipliers: ARRL Sections + Canadian Sections + PA Counties + 1 DX. Each multiplier counts once, not once per band.

- 10.b. Out-of-State Multipliers: 67 PA Counties. Each multiplier counts once, not once per band.
- 10.c. Final Score: Total points times Total Multipliers + Bonus Station Points + other Bonus Points
- 10.d. QRP Operation Multiplier: Multiply QSO Points times 2. Applied only if the entry runs QRP power **AND** enters in a QRP-specific Entry Division or Entry Division that does not have a specified power. In other words, no QRP multiplier is applied to any High or Low Power divisions regardless of actual power used.
- 10.e. PA Mobile and Rover Bonus: Add 500 Points to final score for each PA County you operated from where you made at least 10 valid QSOs.
- 10.f. Accepted abbreviations for PA Counties and ARRL/Canadian Sections are listed on the PA QSO Party website at the following address: <https://paqso.org/pa-cntys-arri-sects.html>.
- 10.g. The PA QSO Party Association will use the Cabrillo file to adjudicate and rescore the log to determine the final results.
- 10.h. **JUDGING:** QSOs will be checked for accurate sent and received QSO elements. QSOs that are determined to be bad after log checking will not be included in the final scoring determination. Report files showing the final score calculations will be available for all entrants after the results are published. A log may be disqualified for violation of amateur radio regulations, unsportsmanlike conduct, incorrect category selection, or an excessive number of bad contacts after log checking. The decisions of the Pa QSO Party Association are final.

## 11. Bonus Station

- 11.a. The PA QSO Party will at its discretion have a special Bonus Station during the Party.
- 11.b. The Bonus Station may consist of a single station or multiple stations in different counties as approved by the party administrator. Bonus Stations use a unique base callsign by county. Distributed Multi-Operator Bonus Station operation within the same county must follow the rules of Section 9.f pertaining to distributed multi-operator stations. Bonus Stations may not operate as a Mobile, Rover, or County Line station. The Bonus Station may consist of a single station or multiple stations in different counties as approved by the party administrator.
- 11.c. Valid QSOs with the bonus station are worth 200 points plus a possible county multiplier.
- 11.d. The Bonus Station(s) for the 2025 PAQSO Party is N3XF and crew, operating from Somerset County.
- 11.e. DELETED
- 11.f. DELETED
- 11.g. Bonus Stations provide a service to the PA QSO Party and have an advantage competing on a level playing field. Therefore, Bonus Stations are not eligible for awards or records. They are also not eligible for first place in a county if there is other activity from that county.

## 12. Entry Materials and Log Submission

- 12.a. Entry materials consist of a Cabrillo 3.0 format log file. It is the participants' responsibility to submit a log that conforms to this format. A Summary Sheet is not

required. The matrix which determines the Entry Division can be found here: <https://paqso.org/pa-qso-party-rules.html>. **Check your Cabrillo file header and be sure to include a valid email address.** Cabrillo log files are to be uploaded at the following web page: <https://paqso.org/log-submission.html>. Fill in all required information, check appropriate categories, and select log file to upload.

- 12.b. **Paper logs or logs in formats other than Cabrillo 3.0 will not be accepted.**
- 12.c. Uploaded logs appear immediately on the [Uploaded Logs](#) web page. Processed logs will appear on the [Processed Logs](#) web page which will be periodically updated as the uploaded logs are processed after the submission window closes. If you uploaded a log and do not see your call in the [Processed Logs](#) on the next update, contact us.
- 12.d. Submitted score is not important. All submissions will be adjudicated and rescored by the PA QSO Party Association. The entered information will be used to determine the Entry Class. The sent QSO information will be used for station location. The QSO Lines are parsed on white space; therefore, column alignment is not important. EPA and WPA multipliers are automatically added during the rescore process – there is no need to enter them.
- 12.e. DELETED
- 12.f. **Log submission deadline is 7 days after the contest.** Please email [info@paqso.org](mailto:info@paqso.org) if you need assistance with log submission.
- 12.g. **DECLARATION:** By submitting a PA QSO Party log, and in consideration of the efforts of the PA QSO Party Association to review and evaluate that log, an entrant unconditionally and irrevocably agrees that he/she has:
  - 1) read and understood the rules of the contest and agrees to be bound by them,
  - 2) operated according to all rules and regulations that pertain to amateur radio for the station location, and
  - 3) accepted that the issuing of disqualifications and other decisions of the PA QSO Party Association are official and final.

If an entrant is unwilling or unable to agree to all of the foregoing, the entrant should not submit the entry or submit the entry as a Checklog only.

## 14. Donations

- 14.a. We are a small organization running a big QSO Party; donations are of greater importance to help keep the Party running. Donations are always welcome to help defray costs for the webpage, printing, and award mailing costs, etc. Donations may be sent through our website securely using PayPal with any major credit card.
- 14.b. Sponsored plaques and awards require sponsor donations.

## 15. Awards

- 15.a. The award information for the PA QSO Party is located here: <https://paqso.org/awards-certificates.html>.
- 15.b. A minimum of 25 valid QSO's in the award category are required for certificates or plaques. This also applies to mobile or rover operators qualifying for an award.
- 15.c. Plaques will only be awarded if there are 2 or more valid entries in the relevant category.
- 15.d. A plaque will be offered to the entrant with the highest score and a Golden Log. The log must contain a minimum of 100 QSOs. In the event of a tied score, the plaque will go to the log with the highest number of QSOs. Certificates will be sent to all entrants with a Golden Log containing a minimum of 100 QSOs. The Golden Log award is not subject to the restriction of Section 15.c.
- 15.e. Club Competition
  - 15.e.1. Four plaques will be offered for sponsorship to recognize the highest club aggregate scores, after log checking, based on the number of logs received as follows:
    - 15.e.1.i In-state club – 26 or more logs
    - 15.e.1.ii In-state club – 5 to 25 logs
    - 15.e.1.iii Out-of-state club (US or DX) – minimum of 5 logs
    - 15.e.1.iv Canadian club – minimum of 5 logs
  - 15.e.2. Participants that want to contribute to a club's aggregate score must correctly identify the club's name at the time of log submission.
  - 15.e.3. Participants in single-operator categories may contribute their scores to a single club and must be a member in good standing of the selected club.
  - 15.e.4. Scores from multi-operator categories may be contributed to a single club. At least one participant of the multi-operator effort must be a member in good standing of the selected club.
  - 15.e.5. The combined scores from mobile and rover operations may be contributed to a single club; individual county scores are not eligible for inclusion in a club aggregate score.
  - 15.e.6. The published results will include a list of club aggregate scores. To be listed in the results, a minimum of three logs must be received from a club.
  - 15.e.7. Club aggregate score calculations include stations operating from any location.
  - 15.e.8. A Club must have a Pennsylvania mailing address to be considered an in-state club.

13. Mobile and Rover submit a single Cabrillo Log File.
14. Eliminated VE1, VE2, etc. in the Canadian abbreviation section.
15. Spotting networks, self-spotting, skimmer, and spectrum scopes are allowed in all categories.
16. Remove specific awards and plaques from the rules and point to where the awards/plaques offered can be found.
17. Awards & certificates moved to separate documents and placed on the website.
18. Entry Classes revised, power measured at the transmitter output.
19. Contact information & log submission updated
20. Use of all authorized amateur bands (except WARC) is allowed.
21. Mobile suggested frequency change to 5-15 kHz.
22. Added a minimum of 25 QSO's for certificates and awards, including mobile & rover single county awards.
23. Combined Mobile and Rover bonus points topics into the Multipliers & Scoring section.
24. Edited the wording in the Purpose of the Party.
25. Removed the Suggested Programs list. This information is on the website.
26. Sept 6: Improved the Sent exchange line to: Sequential serial number plus PA County, ARRL section, Canadian section, or "DX".
